



## WORKSPACE PROTECTION INDUSTRIAL

Protecting industrial workspace has become an increasingly demanding responsibility with security, management and health and safety implications.

### SECURITY

Onwatch has integrated these facilities into a service for effective site security and management, health and safety control and, importantly, a system to prevent, rather than record, unwanted incidents. Some CCTV systems rely on the deterrent of cameras and recordings. The Onwatch site security system detects intruders entering controlled workspace, allowing our central monitoring station (CMS) controllers to observe and, if necessary, warn off the intruder with two-way audio.

With heavy health and safety responsibilities upon employers, the ability to observe and control a range of industrial operations, plus the means to retrospectively audit incidents, has never been greater.

### SITE MANAGEMENT

One or several designated company employees can handle the process of site management during working hours, while our CMS can take over at other times. We use 'activated video' techniques to avoid the need for continuous displays on multiple monitor installations. This means the monitoring process is reduced to individual activations, which can be efficiently controlled, preventing much unlawful activity



### ASSET TRACKING

With embedded equipment installed on mobile plant or carried by lone workers operating in isolated areas, our Onroute service has brought together current technology such as ground positioning system, data transmission via mobile telephone and hand held transceivers into a highly versatile unit with outstanding capabilities. Meeting the legal requirement of employer's duty of care responsibilities is combined with the additional assistance to asset management techniques that can be tailored to individual requirements.
